

A call for paper publishing in the Proceedings of the VIII Sarajevo Days of Psychology

Guidelines for publishing in the Proceedings of the VIII Sarajevo Days of Psychology

The Proceedings publishes theoretical papers, review papers, original scientific papers, professional papers which have been shown and presented during the VIII Sarajevo Days of Psychology, under the condition that they have not been previously published. The manuscripts must be prepared according to the standards presented in this text. The papers which have not been adequately prepared won't be reviewed. The manuscripts are to be delivered to the editor via e-mail: sarajevskidanipsihologije@gmail.com, no later than: **October 15th, 2024**.

During the preparation of your papers, you should abide by the following guidelines:

The paper needs to be written according to the APA 7th edition.

Length of the paper

The paper should be written in Microsoft Word, on an A4 format, font Cambria (font size 12), using the Latin alphabet, line spacing 1,5. The text should be written in such a manner that it is aligned with both of the margins (option *Justify*). The titles should be in bold, whilst the subtitles should be in italic (without numbering the titles). All parts of the text that are to be highlighted should be written in italic (not bolded or underlined). The paper length can be up to 3.000 words (without the abstract, key words, reference list, and appendices). An exemption to this rule are review papers which can be up to 5.000 words as well as the reviews which can be up to 1.000 words long. The editorial board retains its right to publish papers which exceed this text length in cases when the scientific material requires additional text space. Papers with a significant amount of spelling mistakes won't be taken in consideration, as well as those which are not delivered by the, beforehand stated, delivery date.

Language of the paper

The papers in the Proceedings are published in Bosnian, Serbian, Croatian and English language (all written using the Latin alphabet).

Structure of the paper

Aside from the title, the papers should contain following segments: a Bosnian/Serbian/Croatian abstract, an English abstract, an introduction, methods, results, discussion (with the conclusion), list of used literature.

Title of the paper

The title of the paper should be as concise as possible. The length of the title should not be more than 12 words. The title of the paper should be followed by the name of the authors, as well as the name of the institution they are working for. Following the first author's name, there should be a footnote containing a corresponding e-mail address.

Abstract

The abstract should be positioned at the beginning of the paper, with maximal textlength of 350 words. The components of the abstract should be: the aim of the research, methods, the results and the conclusion. The abstract, by default, does not contain any references. Alongside the papers in Bosnian/Serbian/Croatian language, there should be an abstract as well as keywords submitted in English.

Keywords

At the end of the abstract, one must list up to 5 keywords. During the selection of the keywords, keep in mind to pick those which are commonly used to search through journals.

Tables, graphs and images

The tables and graphs should be created in Word (or some Word-compatible format). You cannot display the same results/data using both tables and graphs. Every table, graph or image should be labeled with a number as well as a title that clearly explains them. You should avoid unnecessary lines and shadings. The title of the table, graph or image should be short and informative. Within the text you should refer to the table, graph or image. Tables, graphs and images should be placed at the end of the text (after the reference list), meaning they should not be incorporated in the text.

Reporting results

Report data in order to sufficiently justify your conclusions, and provide an accurate look at what you found in the study. When reporting the results of an inferential statistics, include the obtained magnitude or value of test statistic, the degrees of freedom, exact p-value (except if it is less than .001, in which case it is reported as follows: $p < .001$) and effect size (e.g. $t(68) = 1.54$; $p = .03$, $d = .36$; $F(2,177) = 6.30$, $p = .002$, $\eta^2 = .07$). All statistical symbols that are not Greek letters should be italicized (M , SD , t , r , p), Greek symbols are set in standard typeface (χ , α , β). Use a zero before the decimal point with numbers that are less than 1 when statistic can

exceed 1 (e.g. Cohen's $d=0.70$), and do not use a zero before a decimal fraction when the statistic cannot be greater than 1 (e.g., correlations, levels of statistical significance; $r(24) = -.43$, $p = .028$).

Quotation

Every quote, no matter the length, should be followed by a reference with the page number. For every quote longer than 350 word spaces the authors should have a written approval from the copyright owner, which should also be delivered to the editorial board.

Footnotes and abbreviations

Footnotes are to be avoided. If they are incorporated, they should be at the bottom of the page (but above the page number). Font size should be 10, line spacing 1. Abbreviations should also be avoided, except those which are very common. The said abbreviations which have been enlisted in tables and images should be additionally explained.

References in text

In the papers in the Bosnian/Croatian/Serbian language, the names of foreign authors should be listed in the original form, not in the phonetically-adapted way of writing foreign names. In case of listing multiple authors, they are to be listed alphabetically, not chronologically (e.g., Lazić 1994; Pantić, 1990). If there are two authors of a paper, both are to be listed in the text (e.g. Kuzmanović & Petrović, 2007). If the paper has more than two authors report only the surname of the first author and use the abbreviation „et al.”

Literature

The references must be listed according to the 7th edition of the APA standards at the end of the paper titled Literature. In the actual list of the references, one should only list those which have been used in the text, following an alphabetical order by surnames. Common ways of adequately referencing various sources are described in the following text.

Referencing a book should contain the surname and the initials of the author, year of publication, the title of the book (written in *cursive*), and the publisher.

For instance:

Authored Book:

Kaufman, K. A., Glass, C. R., & Pineau, T. R. (2018). *Mindful sport performance enhancement: Mental training for athletes and coaches*. American Psychological Association. <https://doi.org/10.1037/0000048-000>

A book chapter is to be listed the following way:

Zelege, W. A., Hughes, T. L., & Drozda, N. (2020). Home–school collaboration to promote mind– body health. In C. Maykel & M. A. Bray (Eds.), *Promoting mind–body health in schools: Interventions for mental health professionals* (pp. 11–26). American Psychological Association. <https://doi.org/10.1037/0000157-002>

A scientific article from a journal should contain the surname as well as the initials of the author, the year of publication in brackets, the title of the article, full name of the journal (written in *cursive*), volume (*cursive*) and pages, for instance:

Edwards, A. A., Steacy, L. M., Siegelman, N., Rigobon, V. M., Kearns, D. M., Rueckl, J. G., & Compton, D. L. (2022). Unpacking the unique relationship between set for variability and word reading development: Examining word- and child-level predictors of performance. *Journal of Educational Psychology*, 114(6), 1242–1256. <https://doi.org/10.1037/edu0000696>

A web document should entail the name of the author, year, name of the document (in *cursive*), date when the website was visited, as well as the Internet address to the site:

Taras, Z. (2024, May 30). Situational irony can be funny, tragic or even terrifying. . <https://entertainment.howstuffworks.com/arts/literature/situational-irony.htm>

Referencing unpublished papers (e.g. summaries from academic conferences) isn't desirable but in case such a reference is unavoidable, it can be done the following way:

Lakić, S. (2007, November). *Entrance exam and the average high school grades as predictors of achievement at the Department of Psychology of the University in Banja Luka*. The paper has been presented at the academic conference Banja Luka's November Meetings – Science and the modern social processes, Banja Luka.

In case of referencing an unpublished Master's thesis or a Dissertation, the reference should contain: the last name and the initials of the author, year in brackets, the title of the thesis, a label indicating that the paper is a thesis in brackets, the name of the institution and place. For instance:

Smith, B. (1995). Youth and political participation (unpublished dissertation). Institute of Psychology, Vienna.

If an author is to be referenced multiple times, one should list the references from the oldest to the newest published. In case of referencing multiple papers from the same author which have been published the same year, the years should be labeled with

letters. (e.g. 1995a, 1995b). In case of the reference being longer than one line of text, the text in the remaining lines should be pulled in (using the *hanging* option in Word) by 1cm. The line spacing within a single reference should be 1 and between the references there should be a space.

Referencing to secondary literature should be avoided and used only for those sources which aren't available in any traditional fashion or aren't available in any of the common world languages. In the list of references, one should only list the secondary source.

Appendix

The appendix should only contain material which may be useful in terms of allowing the readers to better understand, evaluate or replicate the research.

Reviews and publishing

All papers will be anonymously reviewed. Based on the reviews, the editorial board will decide regarding publishing the papers. The editorial board will send the review to the authors followed by an adequate explanation behind the decision that has been made. In case the authors decide to revise their text following the guidelines and suggestions of the editorial board, they can resubmit their work for publishing. They are obliged to, in the form of a letter, inform the editorial board of all made changes within the text (with the exact page numbers where the said change has been made). In case the authors consider a certain suggestion, made by the editorial board, unjustified or impossible to fulfill, it's necessary for them to make a detailed explanation as to why they think so. The editorial board retains the right to make the final decision, regarding publishing the paper, independently.

Copyright

The publisher of the Proceedings retains copyrights for all of the papers published, with the added note that the original authors may use their own papers without any additional permission from the publisher. Those authors who intend on publishing their work in the Proceedings are expected to respect and ensure the copyrights of other authors, as well as ensure the rights and dignity of the other participants in the entire research process, adhering to the fundamental ethical principles of publishing scientific papers.
